Subject: Army Special Mission Relocation to Fort Benning, Georgia

1. In support of a unique mission set SDDC expects approximately 500 PCS moves to take place from approximately 68 worldwide locations to Fort Benning between now and September 2017. The below locations have more than 20 shipments inbound to Fort Benning:

- 2. Supporting PPSOs are alerted to review and/or coordinate with the PPPOs for potential volume moves for these or future similar movements. Where practical, volume moves should be submitted to SDDC for solicitation through the Defense Personal Property System as described in the 400NG tariff or International Tender located at <a href="https://www.sddc.army.mil">www.sddc.army.mil</a>. We also ask for continued attention to shipping queues to assure the quickest processing possible.
- 3. TSPs are advised to ensure they coordinate requests for storage in transit (SIT) at destination with the responsible office (JPPSO Southeast) in accordance with the business rules. Origin SIT is discouraged for this mission. Due to a temporary lack of on-base housing availability, we anticipate a greater than average storage in transit requirement. Requests for storage should be coordinated in advance and be based on TSP's knowledge of storage and agent capacity in the Fort Benning area.
